MOE has received funds from the KfW (the German Development Agency) towards the cost of Phase 4 - Component for Rehabilitation of Power Supply Infrastructure, Lot 4, “Procurement of Plant, Design, Supply and Installation of Haditha-Qa'em 132 kV DC Transmission Line”. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract **Lot 4, “Procurement of Plant, Design, Supply and Installation of Haditha-Qa'em 132 kV overhead Transmission Line”** in accordance with Bid requirement.

3. All Bidders must have at least the following experience as Contractor: Completion, as Contractor, of at least three (3) contracts within the last ten (10) years for the design, supply, delivery, installation, testing & commissioning of:
- New construction / extension /rehabilitation of 132 kV Overhead Transmission Lines or higher rated voltage of at least 150 km in length. in the Region (Jordan, Syria, Kuwait, UAE, Saudi Arabia, Turkey, Egypt and Lebanon) and at least 1 of them from Iraq, Total aggregated value of these contracts shall be at least: EUR 50,000,000 (fifty million EUR)
- At least one of these contracts shall be in successful operation for a minimum of three (3) years on the date of opening of technical bids
4. **International competitive bidding** will be conducted in accordance with KfW's Single Stage, Two Envelope Bidding Procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

6. To purchase the bidding documents in English, eligible Bidder should:
- (i) Write to address above request the bidding documents for 2018-MoE EPC-NT4: Lot 4 - Procurement of Plant, Design, Supply and Installation of Haditha-Qa'em 132 kV DC Transmission Line from 30/08/2018 at 8:00 AM to 3:00 PM.
- (ii) Pay a non-refundable fee of 500 Euro (five hundred Euro) in cash. No liability will be accepted for loss or late receipt of bidding documents.
7. Deliver your bid:
- (i) to the address above
- (ii) **on or before the deadline:** 15/10/2018 12 afternoon Baghdad local time
- (iii) together with a Bid Security as described in the Bidding Documents and below.
- Bids will be open immediately after the deadline for bid submission in the presence of Bidder's representative who chooses to attend.
8. The Bid Offer has to accompany by a Bid Security of 920.000 Euro (nine hundred twenty thousand Euro). The Bidder shall include a Bid Security issued by a reputable bank or financial institution requiring KfW's "No-objection".
