General Conditions of Tender

1. General conditions and work description be obtained by general directorate of contracts and sales against unrefundable (100,000 dinars) one hundred thousands dinars (foreign company is not obliged).
2. The bill of tender and general conditions must be attached to offers.
3. Name, number, date and number of bill's tender must be written on the proposals' envelope.
4. Seller must submit (company's brochure) showing similar business certified by contracting entity.
5. Proposals should be put in one envelope contains three separate closed and sealed envelopes on which written name of company and tenders name & no. One envelope contains the commercial offer, the second technical offer and the third company's requested document and to be placed in tender's box in Ministry of Defense's reception room located in Baghdad near al- Jumhuria bridge (international zone .
6. Detailed unit prices against each item beside total prices printed (in digits and writing).
7. Written prices shall be based in case of contradiction with digital prices. Also unit prices shall be based if they contradict the total.
8. Unpriced items shall be considered as per total cost.
9. To submit (2%) of the estimated cost as a bid bond with proposals in form of a certified check or letter of guarantee or svitjh issued by a certified bank according to central Iraqi bank bulletin to the order of Ministry of defense/ General directorate of contracts and sales on which mentioned the name and no. of the tender. Letter of guarantee should be valid to period beyond expiration of validity of the offer or which be extended not less than (28) days. Bid bond to be submitted by seller or (any of participants under a partnership contract). Bid bond of the first three winners will be retained till signing the contract.
10. (5 %) of total contract's value is to be presented (as a final insurance of good performance) after awarding the contract before signing. The insurance letter shall be unconditioned and to paid on order.
11. Bid bond shall not be returned to if winner fails to sign the contract after being informed or withdraws his proposal within validity after closing the tender or his refusal to correct the accounting mistakes (if

there are) and their consequences on awarding the contract ,lawful measures will be taken against him as per government contractual instruction

- 12.The authorized director of many companies is allowed to submit just one proposal in one tender.
- 13.Proposals after the deadline will not be accepted.
- 14.Buyer is not obliged to accept the lowest prices.
- 15.Vender is to present his policy or time table of delivery.
- 16.Vender is to submit a letter of non- objection to participate in tenders issued by general taxes authority (that's for local companies only) addressed to our ministry.
- 17.To submit financial statement and Final account certified by lawful accountant for the last two years.
- 18.Payment is by irrevocable letter of credit (in USD as for foreign companies) and in (Iraqi dinar for local companies via budget of ministry of defense.
- 19.Vender must be manufacturer of good experience and specialization in the requested materials.
- 20.(120) Days validity proposals stating from date of closing.
- 21.Sellers can withdraw their proposals during duration of announcement before the closing date by official order.
- 22.To submit all company documents (certificate or contract of establishment, identity of commercial chamber or equivalent .authenticatated recently or before awarding contract with similar business which will be considered in awarding.
- 23.company which has (commercial agency) must be approved by the mother company authenticated by Iraqi embassy or commercial attaché in foreign in addition to (certificate of establishment issued by companies “registrar of Iraqi ministry of commerce for agents inside Iraq in addition to (establishment certificate or establishment license, rules of company, trade chamber identification with the financial statements of the last two years at least.
- 24.Winner will bear fees of advertisement of the last tender's time.
- 25.Winner Company will bear all taxes and duties imposed by effective law.
- 26.If the closing date coincides to be an official holiday, the next day shall be closing.
- 27.offers have to meet all tender's conditions
- 28.Supplier obliged to submit certificate of origin of all goods authenticated by specialized Iraqi side in country of origin.
- 29.0.002 of the total value shall be paid as per stamp's fee no.71 of 2012.
